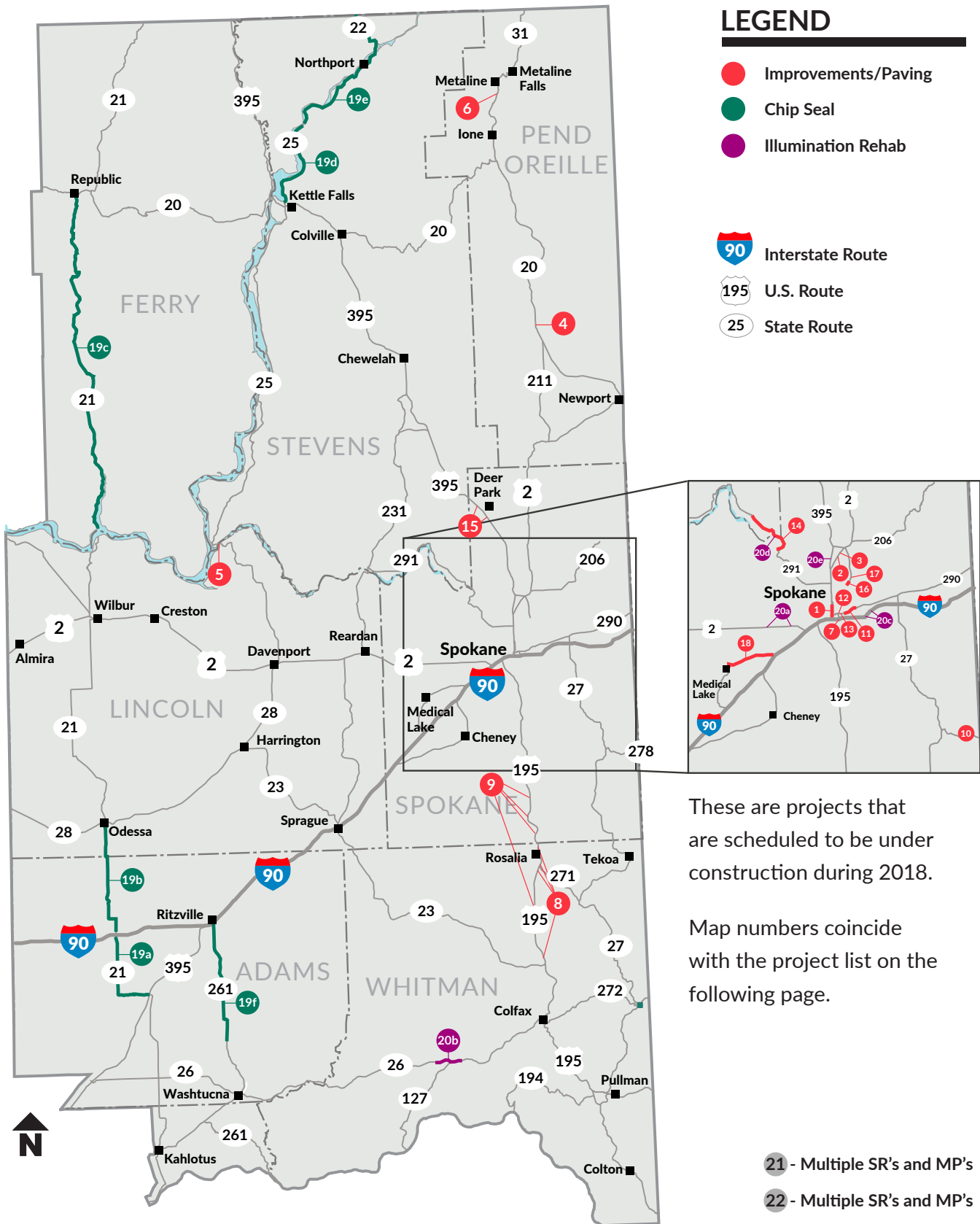


2018 Eastern Region Construction
