

I-405, Northeast 85th Street Interchange and Inline BRT Station Project

Voluntary Submitters Meeting

Monday, February 28, 2022 1:00-2:30 p.m. Online via Zoom

The Washington State Department of Transportation (WSDOT) is beginning the Design Build contract procurement process for the I-405, Northeast 85th Street Interchange and Inline BRT Station Project, funded by Sound Transit. WSDOT will hold an informational meeting for interested contractors and consultants regarding the Request for Qualifications (RFQ) on Monday, February 28, 2022.

The proposed I-405, Northeast 85th Street Interchange and Inline Station Project is located within the City of Kirkland along Interstate 405 (I-405) between milepost (MP) 17.4 to MP 18.9. The Project proposes to replace the existing two-level cloverleaf interchange at NE 85th Street with a threelevel interchange, construct a Bus Rapid Transit (BRT) station, and local improvements along Northeast 85th Street and its intersection with 114th Avenue Northeast/Kirkland Way. Construction is expected to begin in early 2023 and take about four years to complete, with the goal to start BRT service in 2026.

Major scopes of work include:

- Bridge demolition and construction
- Mass excavation, paving, and hauling
- Retaining wall construction
- Storm sewer improvements

Inclusion goals for the Project are set in the amounts of:

- Voluntary goals: 10% Minority / 6% Women
- Enforceable goals: 5% Small / 2% Veteran

The purpose of this information meeting is to discuss the scopes of work in detail, potential opportunities for work, the Design Build procurement process, schedule and next steps. We will also provide time for questions and answers.
